**\*\* 2016 POOL SCHEDULE & RULES AND REGULATIONS \*\***  
**(updated July 25, 2016)**

Memorial Day Weekend May 28<sup>th</sup> – 29<sup>th</sup> & Monday, May 30<sup>th</sup> Pool Open 10am – 8pm

Weekends June 4<sup>th</sup> - 5<sup>th</sup> & June 11<sup>th</sup> & 12<sup>th</sup>, Pool Open 10am – 8pm

Weekdays June 13<sup>th</sup>-17<sup>th</sup>, Pool Open Noon – 6pm

Weekends June 18<sup>th</sup> - 19<sup>th</sup>, Pool Open 10am – 8pm

Weekdays June 20<sup>th</sup>-24<sup>th</sup>, Pool Open Noon – 6pm

Starting June 25<sup>th</sup> through September 5<sup>th</sup> (Labor Day) , Pool Open 10am - 8pm

**ALL USE OF THE POOL AREA, INCLUDING SWIMMING, SHALL BE AT YOUR OWN RISK**

**\*\*THE BOARD OF DIRECTORS, MANAGEMENT, AND THE POOL STAFF HAS FINAL AUTHORITY CONCERNING ENFORCEMENT OF THE RULES AND REGULATIONS\*\***

1. All members or their guests utilizing these facilities do so at their own risk. When a lifeguard is not on duty, all swimmers must temporarily leave the pool until he/she is back on duty.
2. The pool area is for use by residents (and their guests). Please make sure to close the gates securely behind you when entering and leaving the pool area.
3. A resident must accompany their guests at the pool. **Residents may NOT use the gated pool area to hold any type of party.** If there is overcrowding, the number of guests will be limited. Guests are expected to adhere to all pool rules. Children under 16 may not bring guests to the pool without an adult.
4. When a resident plans on bringing eight or more guests 16 years old or younger to the pool at one time, our managing agent, Joe Sofield, must be contacted (via email @ jsofield@nailongisland.com ) at least two weeks in advance so that we are able to schedule an additional lifeguard to ensure that the appropriate level of pool safety is maintained. We encourage you to contact Joe as early as possible, since bringing in the aforementioned guests is contingent upon us being able to schedule the additional lifeguard. The resident making the request will be responsible for the \$250 lifeguard cost even if their plans change, or the weather is unfavorable, unless cancelled in writing to Joe at least three business days in advance of the scheduled agreement.
5. **ALL parents who have a child in the water must supervise that child at all times, and maintain visual contact with them. Do not walk away from a child who is in the water, as parents are primarily responsible for their children.**
6. Floats and other water toys will only be permitted in the pool if they do not interfere or disrupt enjoyment of the pool by others. If the lifeguard deems same to be objectionable, they must be removed immediately at the request of the lifeguard.
7. Resident's children 16 years and under must be accompanied by an adult who is at least eighteen 18 years of age. Youngsters between the ages of 12 and 16 will be permitted in the swimming pool area without adult company if there is a formal written request signed by their parents. Children must obey the rules and the directions of the lifeguard. If they do not obey these pool rules and the directions of the lifeguard, they will have to vacate the pool area and will no longer be permitted in the pool area unless an adult at least 18 years of age accompanies them.



8. Music may be played as long as no one is disturbed. Running, pushing, and any other boisterous play are prohibited.
9. Only drinks in water bottles or jug type plastic containers and those served in paper or plastic cups are permitted. NO glassware or breakable containers are permitted at any time for safety reasons. NO alcoholic beverages are allowed.
10. Food is permitted in the pool area. **You are responsible to clean up after yourself or any of your guests.**
11. As mandated by the Board of Health, the pool is for swimming. No urinating or defecating, or nose blowing in the pools. Infants, toddlers and any other child not fully bathroom trained cannot go into the pool unless they are wearing SWIM DIAPERS, NO EXCEPTIONS. Our lifeguards have the right and the responsibility to question any parent or guardian if they believe this policy may be violated. **In the event of a violation of this policy, the violator will not only be assessed a fine, but will also be billed for the cost of chemical treatment.**
12. DIAPERS MUST BE DISPOSED OF PROPERLY. You are responsible to bag any soiled diapers securely in a sealable plastic bag and discard them properly. If you leave a dirty diaper in the pool area, you will be subject to a fine and possible denial of pool usage.
13. Lounges and chairs are primarily for use by residents, and may not be reserved.
14. Diving or jumping off the poolside is expressly prohibited.
15. All pets are forbidden.
16. Please respect your neighbor's rights. Avoid unnecessary noise or improper conduct.
17. Pool ladders are for entering and exiting the pool only. Sliding and hanging on ladders or railings are prohibited. Strollers must be kept far away from the edge of the pool, and brakes must be on at all times. We encourage you to park empty strollers and wagons outside the pool area, reducing clutter and avoiding possible injuries.
18. Residents must leave pools and pool areas when it is raining, thundering and/or lightning for a minimum of thirty (30) minutes, or until the lifeguard deems it safe to return. If the weather clears up before two (2) hours of the scheduled closing, the pool will re-open; otherwise, the opening of the pools will be based at the lifeguard's discretion.
19. Positively no smoking permitted inside the pool or playground areas.

A lifeguard will be on duty during normal operating hours. The lifeguard will have a chair and umbrella for their exclusive use. Residents **may not** remove the chair or umbrella for personal use.

The lifeguard is in charge of the pool and pool area. EVERYONE – adults and children – must respect the lifeguard's decisions. If you have any problems or concerns that the lifeguard cannot address, please call NAI Long Island. Lifeguards have been instructed to notify NAI or Board members at the pool, or to call security in the case of uncooperative residents.
